

MINUTES FOR GARRETT HILL STEERING COMMITTEE MEETING FOR AUGUST 19, 2008

The Garrett Hill Steering Committee (GHSC) met on Tuesday, August 19, 2008 at the Radnor Township Building, 301 Iven Avenue, St. Davids, PA for its scheduled weekly 7 pm meeting.

Present were Chair Rick Barker, Vice Chair Phil Ahr, Secretary Jim Cunilio and Committee members Nancy Leinwand, Rick Eulo and Jerry O'Connor. Not present was Committee Member Le Turner, Bob Adams and Betty Lou Norcini. Members of the public were present including Commissioner John Fisher.

Call to Order

The meeting was called to order by Barker at 7:06 pm and Barker lead everyone present in the Pledge of Allegiance.
